In return for the use, today and on all future dates, of the property, facilities and services of Hunter Farms, regardless of where they are rendered, The RIDER, his heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. It is the sole responsibility of the RIDER to carry full and complete insurance coverage on his horse, personal property, and himself.
2. RIDER agrees to assume ANY AND ALL RISKS INVOLVED IN OR ARISING FROM RIDER'S USE OF OR PRESENCE UPON HUNTER FARMS' PROPERTY AND FACILITIES including, but not limited to, the risk of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.
3. RIDER agrees to hold Hunter Farms and all of its successors, assigns, subsidiaries, franchises, affiliates, officers, directors, employees and agents completely harmless and not liable and releases them from all liability whatsoever and AGREES NOT TO SUE them on account of or in connection with any claims, causes of action, injuries, or damages, including consequential damages.
4. RIDER agrees to waive the protection afforded by any statute of law in any jurisdiction whose purpose, assistance, and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
5. RIDER agrees to abide by all of Hunter Farms' rules and regulations.
6. RIDER agrees to wear an approved hard hat whenever mounted.
7. If the RIDER is using a horse, or is shipping his horse with Hunter Farms, the horse shall be free from infection, contagious or transmissible disease. Manager reserves the right to refuse the horse if not in proper health or if the horse is deemed dangerous or undesirable.
8. This contract is non-assignable and non-transferable and is made and entered into in the State of New Jersey, and shall be enforced and interpreted under the laws of this State.
9. Hunter Farms has the right to obtain medical help for the RIDER if parent of guardian cannot be reached.
10. When Hunter Farms and RIDER or RIDER'S parent or guardian, if RIDER is a minor, sign this contract, it will then be binding on both parties, subject to the above terms and conditions.
